- 5.3 The Association has no obligation to continue payments and may at any time modify, suspend, or cease providing honorarium payments without notice.
- 5.4 The Recipient is solely responsible for any taxation obligations arising from receipt of the honorarium. The Association provides no advice or representation regarding the tax treatment of this honorarium.









5.5 The honorarium is exempt from superannuation contributions and any entitlements or protections provided under the Fair Work Act 2009 (Cth).

## 6. No Employer Obligations:

The Recipient expressly acknowledges and agrees:

- 6.1 Their participation is voluntary, without entitlement to any employee-related benefits, such as paid leave, superannuation, workers' compensation, or remuneration under any industrial award or workplace agreement.
- 6.2 They have no obligations regarding set hours, tasks, or reporting structures consistent with an employment or contractual service relationship.

# 7. Termination of Honorarium Agreement:

This Agreement may be terminated at any time by either party by providing written notice. The Association may immediately cease providing honorarium payments if the Recipient ceases involvement or their role with the Association ends.
